ELECTRONIC MULTI-TONE RINGER

GENERAL

The V-9943A is a Line-Powered Electronic Multi-Tone Ringer which is designed for use in an office environment with a quiet to moderate ambient noise level. The V-9943A can be connected to a C. O. Line, PABX Station, or common audible contact to provide a selectable tone and an LED indication to indicate the presence of incoming calls.

The V-9943A has received FCC Registration Number BAFUSA-19316-RG-N and has a ringer equivalency of 2.2A. The unit is designed to be used with FCC registered Telephone Systems and installations may be made by Valcom, Inc., equipment manufacturers, telephone companies, registered telephone refurbishers, and those qualified for installation of FCC-registered systems under FCC Rules Section 68.215.

In accordance with FCC Rules with applicable tariffs, this Ringer may only be installed with the authorization of the owner of the host system.

The FCC Registration Number will be listed in the affidavits filed with the telephone company; it will also be recorded in the system log kept by installation and maintenance personnel. The local telephone company is to be notified of the FCC Registration Number when this Unit is installed.

An RJ11C jack is required for direct interconnection with the telephone network.

SPECIFICATIONS

Design

The V-9943A is designed to give incoming call indication. Incoming call indication is recognized as an interrupted tone and a light. The tone can be a solid or warble tone. Different frequencies can be selected using DIP switches (See Option Switch Chart).

- Provides a tone indication when a call is ringing in.
- Switch selectable tone(s).
- Volume control.
- LED indication of incoming call.
- Separate power supply not required.
- Screw terminals for all connections

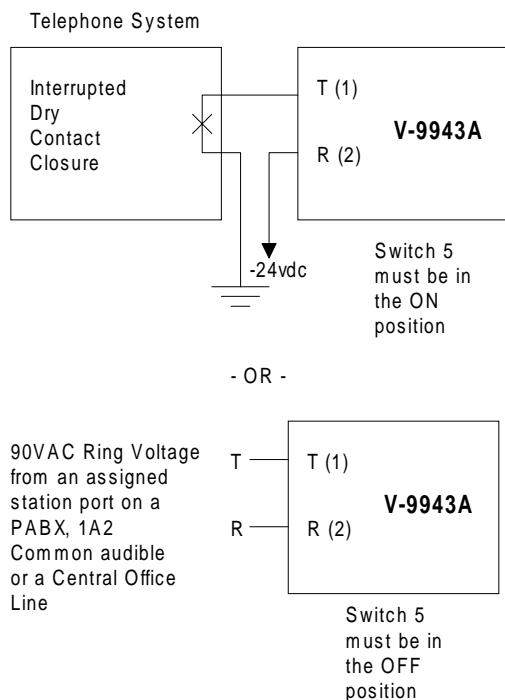

Power Requirements

70-105 Vac (20-30 Hz), 50 mA max. or -24 Vdc, 50 mA max.

INSTALLATION/OPERATION



The V-9943A is activated by 70-105 Vac (ring voltage) or -24 Vdc (normally through an interrupted contact closure). If the V-9943A is to be connected to the telephone network, two wires should be secured to the screw terminal connection on the PCB. The other end of the wires should terminate at a RJ11C jack.

An LED provides a visual indication when the unit is activated.

The tones are dipswitch selectable. The various tones available are described in the Option Switch Chart along with the switch configuration necessary to obtain the tone.

The dip switches and volume control are accessed through the opening in the rear of the enclosure.

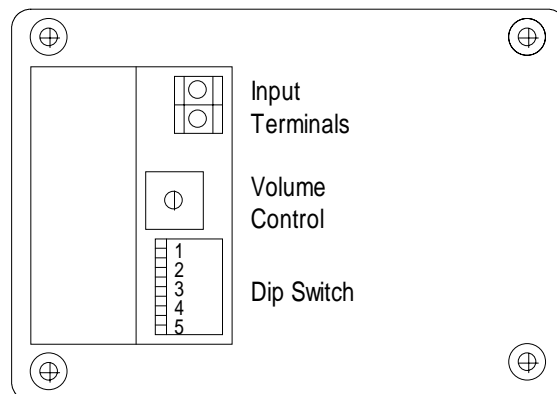
A. Setting the Dip Switches

Switches 1-4 determine tone. Switch 5 determines AC or DC operation.

1. Determine if the equipment will be used with AC or DC current. For DC current SW5 should be in the ON position. For AC current (ring voltage) SW5 should be in the OFF position.

CAUTION: Do Not Use Ring Voltage with SW5 in the ON position.

2. Switches 1, 2, 3, and 4 set the tones. Refer to the Option Switch Chart to obtain the setting of the desired tone.



B. Setting the Volume Control

The volume control is screwdriver adjustable. During initial setup, it is recommended the volume control be set 1/4 turn clockwise.

C. Mounting

The V-9943A has mounting holes located on the sides of the unit. Two #10 x 3/4" wood screws are included for mounting purposes.

TECHNICAL ASSISTANCE

Assistance in troubleshooting is available from the factory. When calling, you should have a Volt ohm meter and a telephone test set available and be calling from the job site. The V-9943A can be used as a contact closure with dip switch 5 ON.

For ring voltage, dipswitch 5 should be in the OFF position.

NOTE: Dip switch positioned Up = OFF; Dip switch positioned Down = ON.

4. freight charges for the return of products to Valcom are prepaid,
5. all units 'out of warranty' are subject to a service charge. The service charge will cover minor repairs, (Major repairs will be subject to additional charges for parts and labor).

This warranty is in lieu of and excludes all other warranties, expressed or implied, and in no event shall Valcom, Inc. be liable for any anticipated profits, consequential damages, loss of time or other losses incurred by the buyer in connection with the purchase, operation or use of the product.

This warranty specifically excludes damage incurred in shipment. In the event a product is received in damaged condition, the carrier should be notified immediately. Claims for such damage should be filed with the carrier involved in accordance with the F.O.B. point.
